- (10) Any casual vacancy in the Board of Trustees shall be
- filled up by the Managing Trustee by appointing one among the trustees in the Board Meeting in consultation with the Board of Trustees.
 - The Managing Trustee is empowered to appoint his successor, i.e. Managing Trustee from among the existing Trustees.
- (11) The Managing Trustee of the Trust shall have overall Management of the activities of the Trust and shall in particular have the power to operate bank account, employ servants and others, and otherwise deal with the funds of the Trust.
- (12) The Board of Trustees on behalf of the Trust are empowered to receive donations and other amounts from Trustees and from outsiders in India and abroad as may be found necessary from time to time.
- (13) The Board of Trustees are empowered to borrow funds for the Trust from banks or others with or without security.
- (14) The Board of Trustees shall have the power to acquire, hold, enjoy and deal with and dispose off properties of every description for and on behalf of the Trust.
- (15) The funds of the Trust shall be invested in Bank deposits, Government Bonds or such other appropriate securities as the Board of Trustees may decide from time to time.
- (16) The Board of Trustees are empowered to construct, purchase buildings and otherwise improve or renovate such properties.
- (17) The Board of Trustees may empower the Managing Trustee to represent or act for the Trust in matters concerning the properties, funds, investments, borrowings and any other assets/liabilities of the Trust.

- (18) The Board of Trustees shall have power to invest funds of the Trust in immovable properties and/or improve or in construction of buildings, etc.
- (19) The Board of Trustees are empowered to let or lease the properties of the Trust.
- (20) The Board of Trustees shall maintain or cause to be maintained proper and regular books of account and shall make up accounts every year as on 31st March and the accounts shall be audited by a Chartered Accountant.
- (21) All acts and proceedings of the Trust shall be taken and conducted in the name of the Trust and the decision of majority shall prevail. In case of equality of votes, the Managing Trustee shall cast his/her vote.
- (22) No part of income or assets of the Trust shall be transferred or applied at any time for any purposes other than those set out in clause (2) above.
- (23) The Board of Trustees are empowered to make rules for the proper governance or administration of the Trust but such rules shall not be against the objects of the Trust.
- (24) The income and funds of the Trust shall be solely utilized towards the objects of the Trust and no portion of it shall be utilized for payment to Trustees by way of profit, interest, dividends, etc.
- (25) Any amendment to the trust deed shall be carried out only with the approval of the Commissioner of Income-Tax.
- (26) If any amendments, additions or deletions is decided by the Board of Trustees, the same shall be effected through supplementary deed/deeds signed by all Trustees and the same shall be read together with the main deed.
- (27) The Trust shall not carry on any activities outside India.
- (28) The Trust shall not carry on any activity with the intention of earning profit.

- (31) It is made explicitly clear that there is no immovable property in the name of the Trust at present and that no immovable properties are settled by this deed.
- (32) It is hereby expressly declared that this trust is a Charitable Trust and the Trust hereby created is IRREVOCABLE.
